Onanole Foundation History

In 1965, a group of Onanole residents, Fred Minty, Bill Stewart, Bill Piett and Stan Shuttleworth, started a land development company. Other contributors were brought into the company at later dates. This group developed the land that is now known as Grey Owl Estates. This parcel of land became one of the first land condominiums in Manitoba. It was agreed that a portion of money raised from the development of this land would be put into a fund that would be made available to benefit the community of Onanole on a long term basis. This was the beginning of the Onanole Foundation.

The Onanole Foundation was incorporated on November 21, 1984. The first directors of the Foundation were Fred Minty, George Allard, Warner Laurence Buck, and Norman Harper Sims.
