**WHEREAS** the Non-Profit Organization hereby confirms it is a not for profit organization;

**AND WHEREAS** the Non-Profit Organization has undertaken a project for which it has applied to the Tiger Hills Community Foundation Inc. for financial support;

**AND WHEREAS** the Qualified Applicant recognizes that the Non-Profit Organization has planned a worthy project (as hereinafter described) with which it wishes to proceed;

**AND WHEREAS** the Non-Profit Organization is not a Qualified Applicant and is therefore unable to apply to the Tiger Hills Community Foundation Inc. (hereinafter referred to as the “Foundation”) directly for a grant in support of the project;

**AND WHEREAS** the Qualified Applicant is a Municipal/School Division/Hospital/Charitable Organization and, as such, it is eligible to apply for and to receive grants directly from the Foundation;

**AND WHEREAS** the Non-Profit Organization’s project is not inconsistent with the mandate of the Qualified Applicant and will benefit its citizens should it proceed;

**NOW THEREFORE THIS AGREEMENT WITNESSETH:**

1. The preamble shall form an integral part hereof.
2. The Qualified Applicant shall apply for a grant from the Foundation for the following project: \_\_\_\_\_
3. The Qualified Applicant hereby confirms that the project of the Non-Profit Organization is not inconsistent with the mandate or by-laws, if any, of the Qualified Applicant.
4. The Qualified Applicant hereby covenants that in the event that grant application is successful, the monies paid to the Qualified Applicant by the Foundation will be immediately paid by the Qualified Applicant to the Non-Profit Organization.
5. The Qualified Applicant shall have no other financial obligation to the project other than jointly applying for the grant and delivering the proceeds to the Non-Profit Organization should the grant application be successful.
6. The Non-Profit Organization hereby confirms that the control, implementation and administration of the project as well as the payment for the project shall rest fully with the Non-Profit Organization.
7. Time is of the essence hereof.
